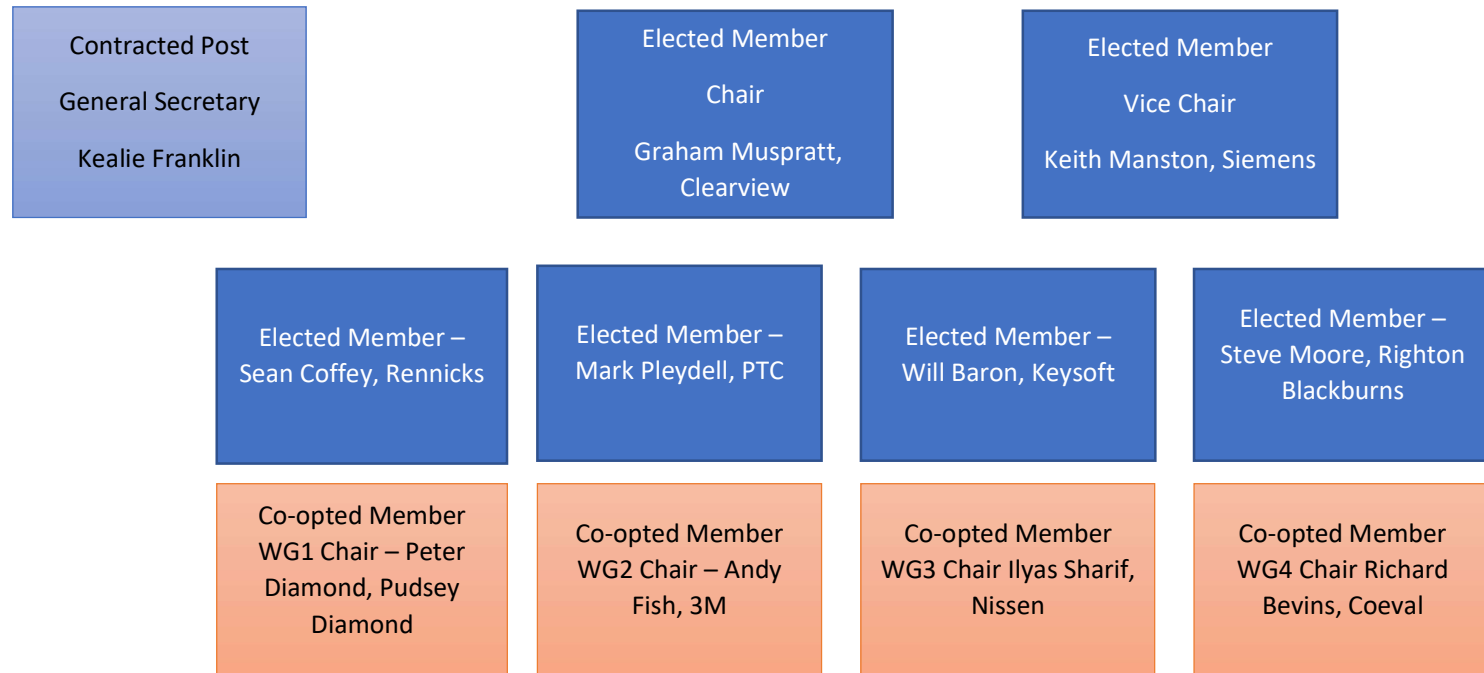


THE EXECUTIVE COMMITTEE November 2019
